#### NOTICE OF REINVESTMENT FEE COVENANT

The Burdened Property only includes the fifty-two (52) townhome Units in Fairway Village and does <a href="mailto:notion">not</a> include the twelve (12) single family home Lots in Fairway Village. The twelve (12) single family home Lots are <a href="mailto:notion">not</a> subject to the Reinvestment Fee Covenant.

This Burdened Property is subject to the First Amendment and Restatement of the Amended, Combined, and Restated Declarations of Covenants, Conditions, and Restrictions for Fairway Village No. 1 Subdivision and Fairway Village No. 2 Subdivision recorded with the Summit County Recorder on December 17, 2009 as Entry No. 00888582, and any amendments or supplements thereto (the "Declaration").

The Reinvestment Fee Covenant requires, among other things, that upon the transfer of any of the Burdened Property subject to the Declaration, the transferee is required to pay a reinvestment fee, unless the transfer falls within an exclusion listed in Utah Code § 57-1- 46(8). In no event shall the reinvestment fee exceed the maximum rate permitted by applicable law.


